

5. Diagram of on-site parking lot and parking space configuration (i.e., right-angle vs. angled, single-loaded vs. double-loaded);
6. Proposed location of the business vehicle on the site(s);
7. Dimensions from proposed mobile business operations to all permanent buildings, drive aisles, and driveways;
8. Location of any temporary electrical hookups;
9. Location of any furniture, solid waste containers, and similar fixtures to be placed in the immediate vicinity of the mobile business.

In addition, please provide the following documentation, in accordance with CMC 5.35.070:

1. Written permission from the owner, leasing agent, or person in charge of the property at which the business will operate (see attached sheet).
2. A copy of the applicant's current City business license.
3. A copy of the applicant's current food handler certificate (if applicable).
4. Depending on the Mobile Vendor Type:
  - a. **Type A:** A copy of the applicant's current certificate of insurance, which shall include, as a minimum: Commercial General liability policy of \$2mm per occurrence, workers compensation, and auto liability.
  - b. **Type B:** A copy of the applicant's current certificate of insurance only.

I, the undersigned, as the applicant or applicant's appointed representative, do affirm that I will locate and operate the mobile vendor unit in accordance with all regulations in Chapter 5.35 of the Cornelius Municipal Code. I also acknowledge that I may not operate a mobile business until I have been issued a Business License from the City of Cornelius.
